#### **UNFINISHED BUSINESS—**

Retail Business Design Workshops. Aaron Backman reported the workshops have been going well. There are 18 businesses of a wide variety participating of which three-fourths are women-owned and three are diverse businesses. Connie Schmoll reported the speakers have been very well received and have been scheduled by the University of Minnesota Extension and College of Design. Each workshop has been recorded. Backman and Schmoll reported on the various workshops that have been held. Sarah Swedburg reported coaching sessions will allow the participants an opportunity to dig deeper into the material being presented for their individual businesses. Participants have given positive feedback and collaborative conversations are being held between the businesses. There are two workshops and coaching sessions remaining. The workshops have been held at Bremer Bank, Willmar Public Library and will be at WORKUP. The fee was \$250 and all participants received some type of scholarship.

Willmar Child Care Center Update. Schmoll reported the EDC closed on its loan to the Willmar Child Care Center. Southwest Initiative Foundation will close once it receives documents relative to renovation of the building. An outdoor sign has been installed. The Center will have room for 90 children. Schmoll reported the county childcare leadership group continues to work. The YMCA chose the Green Lake Mall for its Spicer location and it will have room for 90 children. Plans are for the center to open this summer. The YMCA is also planning a childcare for infants and toddlers with 60 spaces to be located within a Willmar church. Backman gave an update on a proposed senior housing facility being planned for New London that may include a childcare center for 60 children. Schmoll reported the county group is hearing from childcare providers and Kandiyohi County Health & Human Services, who have thanked the group for working on a solution to childcare needs in the county.

Business Visits and Meetings. Backman reported he and other Highway 23 Coalition members testified before the House Transportation Finance and Policy Committee in St. Cloud. Donna Boonstra reported the majority of the testimony at the hearing was on the Northstar Metro Transit. Backman and Schmoll met with a housing developer from Sioux Falls, who is interested in doing a mixed-use housing using Opportunity Zones. The Highway 23 Coalition will hold its annual membership meeting Friday, March 22<sup>nd</sup>, at The 400 Club Restaurant & Lounge. The West Central Area Job Fair will be held March 26<sup>th</sup> at Ridgewater College from 12 to 5:00 p.m. There are close to 60 vendors registered with 8 being new to the Job Fair. Schmoll noted the task now is to get job seekers to attend. Schmoll reported the Ag Committee formed a subcommittee to explore processing industrial hemp. The Kandiyohi County Sheriff attended the subcommittee's last meeting and will continue to give oversight. Charles Levine, a grower and processor from Waconia

also attended and is seeking additional growers. Levine is processing oil for vegetables and feed. Schmoll will be attending a Canada food show with the Minnesota Department of Employment and Economic Development. Schmoll reported on business visits from her written report (see attached).

New Business—There was no new business.

### **Child Care**
