Chairperson Mark Boeschen called the meeting to order at approximately 12:04 p.m. and declared a quorum was present.

MINUTES-

IT WAS MOVED BY Donn Winckler, SECONDED BY Michelle Marotzke, to approve the Minutes of the March 4, 2019 meeting as emailed. MOTION CARRIED.

UNFINISHED BUSINESS-

Presentations to Townships. Michelle Marotzke, Dave Sisser and Ramsey Schaffnit attended the Green Lake Township meeting last Thursday night. Marotzke reported a TDS representative was at the meeting requesting a franchise for IP TV. A big concern for the township was that the township is covered by two providers, TDS and CenturyLink. If the EDC partners with one provider for a project, will that provider only cover their territory and not the part of the township covered by the other provider. Dave Sisser reported TDS has some fiber to the nodes, but nothing to populated space. TDS has fiber runs through a good portion of Green Lake Township.

[Les Nelson joined the meeting.]

Committee members felt it may be worth speaking with TDS to see if it is willing to partner on a project. The township representatives received good education about fiber and wireless. Approximately nine people attended the meeting, most of whom were township board members. Attendees expressed their dissatisfaction to the TDS representative in attendance. It was good for TDS to hear about broadband in the county. The township is to contact Connie Schmoll if they are interested in having a public meeting. The township was concerned that everyone would be taxed. Schmoll's PowerPoint Presentation used at the township meeting was distributed to the

committee (<u>see</u> attached). The presentation included information about fiber to the node and fiber to the premise and why they are superior to copper. Ramsey Schafnitt stated the slide with the website for speed testing needs to be corrected to <u>www.checkspeedminnesota.com</u>. This should be done before other presentations are given. Presentations are scheduled with St. Johns Township on April 8th at 1:30 p.m. at Pennock City Hall and Mamre Township at 8:00 p.m. Marotzke will attend and Sisser will try to attend both meetings.

New Business—There was no new business.

REPORTS

Minnesota Rural Broadband Coalition. Chair Boeschen reported Schmoll, Donna Boonstra and Roger Imdieke will be attending Broadband Day at the Capital on April 3, 2019. Rollie Nissen indicated he may also attend. Meetings are set up with Senator Lang at 11:30 a.m. in a committee room and with Rep. Baker at 2:00 p.m. at the State Office Building and 11:30 a.m. It was the consensus that this committee's message to the legislators is to continue funding for the Office of Broadband and the state grants and that the incumbent policy relative to the state grant application remains an issue. It was reported that a provider cannot use CAF II and the state grant for one project. Sisser reported TDS has not done any of the work it promised during the last grant process. Scott Froemming asked if any language has been drafted relative to changing the incumbent policy? Boonstra replied that language was submitted a couple of years ago, but it was not approved.

[Gregg Price joined the meeting.]

Meeker County project. Froemming reported he and Schmoll met with Tim Mergen of Meeker Cooperative Light & Power Association as to its \$23 million broadband project. Meeker Cooperative is using RUS (Rural Utilities Service) funds for fiber to substations and no other grants. The first part of its project is fiber to the substations and then installing 45 120' poles for fixed wireless. The cost to cover Meeker County is \$70 million. It is installing 150 miles of fiber backbone and 120 miles fiber-to-the-home (FTTH). It will be 50/50 underground vs. overhead. Meeker Cooperative is working with Pulse and NeoNova out of Raleigh, North Carolina, to design and build the service packages and billing processes. The project will create 10 new jobs—five have already been hired. They are advertising 25/3 as the speed, but FTTH will do better.

[Roger Imdieke joined the meeting.]

One issue Meeker Cooperative has encountered is working with landowners to install poles on their property. Its service is called Vibrant Broadband. The program has managed services where Meeker Cooperative can look into the home for issues. It is still working on the back haul part. CenturyLink and Windstream fell through; it is now looking to work with Arvig. One of the companies did the study. The cost for minimum service is \$65 less \$5 per month for members. The estimated completion is in two years; the first phase will be done this year and the second phase next year. Meeker Cooperative estimates it will start making money in 10 years. It is

covering its entire service area, which includes part of Kandiyohi County. There was good public support. The project has some competition with MVTV, LTD, Arvig and HughesNet.

Donn Winckler announced Meeker County recently lost its economic development staff person.

Schaffnit stated speed test reports are done by the number of pings by zip code. Boeschen stated that is not really a valid test. The website does ask what kind of equipment you are using. Roger Imdieke stated the National Association of Counties uses <u>www.naco.org/testit</u> for speed tests.

Sunrise Township (CenturyLink) Fiber to the Home - Grant: \$1,074,852 Total eligible project cost is \$2,388,560. Local match is \$1,313,708.

This last mile project will serve 584 unserved households, 10 unserved businesses, and 2 community anchor institutions in rural Sunrise Township in Chisago County, MN. In a funding partnership with the State of Minnesota and Sunrise Township, CenturyLink will leverage CAFII funding from the FCC to bring 1 Gigabit service to two-thirds of the township, exceeding the 2026 state speed goal of 100 Mbps by 20 Mbps. When Stepp Manufacturing based in the township found that one of their highest operating costs was broadband, they started making calls to CenturyLink, Sunrise Township, and the Chisago County HRA-EDA. That resulted in the entire community working together, including a township match of nearly \$600,000 in bonding, to secure the fiber-to-the-home project and improve business, education, health care, and telecommuting opportunities in the area.
