#### **MINUTES**

Chairperson Dan Tepfer called the meeting to order at approximately 7:35 a.m.

**AGENDA**— Chair Tepfer presented the August 16, 2018 agenda. The agenda was approved as emailed.

#### MINUTES—

IT WAS MOVED BY Rollie Boll, SECONDED BY Dan Lippert, to approve the July 19, 2018 agenda as emailed. MOTION CARRIED.

Kim Larson inquired the attendance status of a member. Schmoll will contact John Harren to recommend a prospect from Willmar Municipal Utilities.

Larson mentioned he has invited Sarah Leshuk of Kandiyohi County Corn & Soybean Growers, to attend a future Ag Committee meeting. Schmoll will invite her to the next Ag Committee meeting.

#### REPORTS—

**Ag Marketing and Event Planning Subcommittee.** The Ag Marketing and Event Planning Subcommittee will meet next week to recap the Talent & Technology workshop and review the evaluation summary.

**2018 Talent & Technology Workshop Recap**. Schmoll presented an overview of the Talent & Technology workshop and reported it was a successful event. She distributed the attendance list (<u>see</u> attached). There were 59 with 53 attending, which includes 28 from sponsors. Boll inquired if there was feedback on the online registration system. Schmoll shared initially a fee of \$3 per

registrant was charged; however, this was eliminated and they are working on returning that fee to those who were charged. She felt it was beneficial to have both options of online credit card registration and direct calls to the EDC office to send a check. A discussion was held regarding attendance fees versus sponsorship fees. Chair Tepfer felt attendance fees should be charged; committee members concurred. Committee members also concurred the advertising methods were excellent. Schmoll reported the EDC's intern posted numerous social media ads; radio ads and newspaper ads were also used. Schmoll inquired if a direct mailing should be considered; committee members concurred. Chair Tepfer suggested to determine the audience type when advertising an event. Schmoll commented direct calls and personal contacts was the most effective. Lippert suggested sending direct mailings approximately 10 days prior to an event. Other suggestions for a future event included:

- Timing of the event
- Clear registration options
- An addition to the evaluation form: How did you find out about the event?
- Print agenda topics on back of name tags
- Include speaker presentation handouts in folders
- Omit advertising flyers in folders
- Discussed speakers' presentation information. Audiences prefer specific information.

Boll inquired if attendees took advantage of the reduced golf rate. Schmoll was not aware of anyone who golfed and commented if the option is offered again, golf teams would be formed.

Graue acknowledged the great work of the Ag Marketing and Event Planning Subcommittee on planning the successful event. The next Ag Committee agenda will include discussion for a future event. Schmoll welcomed committee members sending suggestions for a future event prior to Monday when the Ag Marketing & event Planning Subcommittee will meet.

#### **UNFINISHED BUSINESS**

**trū™ Shrimp**. A site visit is being planned for EDC staff and a Kandiyohi County Commissioner. Schmoll will give a report at a future Ag meeting.

**Simply Shrimp.** Chair Tepfer talked with Paul Damhof of Simply Shrimp regarding the recent grant which was received. He mentioned the marketing of trū™ Shrimp versus Simply Shrimp. Damhof is looking at fresh market versus the trū™ Shrimp frozen product which is distributed by other avenues. There does not seem to be any competition in their markets.

#### **NEW BUSINESS**

**Proposed 2019 Ag Budget.** Schmoll distributed the approved 2019 EDC Ag Committee budget (see attached) as approved by the EDC Joint Operations Board and the EDC Joint Powers Board. Schmoll noted the proposed Industrial Hemp Value-Added Study of \$5,000 was approved and commented this will enable the Ag Committee to work with partners to study the value of the industrial hemp, i.e., products etc. Chair Tepfer commented the 2019 budget is approximately \$2,000 less than the 2018 budget and that Marketing and Professional Services amounts were omitted in order to budget for the Industrial Hemp Value-Added Study. A discussion was held regarding the \$7,000

budgeted for Ag events and felt an event is self-sustained and suggested it not be included as a budget item. Boll will visit with Aaron Backman. Schmoll commented the Ag Marketing costs, other than the event, were moved to the Marketing Committee expense line. The Ag Committee will prepare a list of future funding proposals at a future meeting.

#### **New Business**

**Ag Tour or other event for committee members.** Chair Tepfer suggested Ag Committee members participate in tours of various new business operations, i.e., Simply Shrimp, Lettuce Abound, etc.

Larson inquired how the Ag Committee plans to raise funds for the Industrial Hemp Value-Added Study. Schmoll stated funds will come through grants, etc. Larson shared Hultgren Farms has planted 40 acres of organic industrial hemp and Larson's son and Noah Hultgren will be attending a class in Wisconsin regarding how to harvest the crop. Harvest may begin on September 15<sup>th</sup>; Ag Committee members voice interest in a tour of the Hultgren's hemp crop. Larson will ask Hultgren for permission and send the details to Schmoll, who will email the information to Ag Committee members. The Ag Committee concurred to visit the industrial help harvest on September 15<sup>th</sup>, if approved, and visit the other new businesses later this year/winter. Larson suggested inviting a representative from the Soybean Association to a future Ag Committee meeting to discuss available projects. Schmoll suggested inviting Shannon Schlep of AURI to a future Ag Committee meeting to present information on industrial hemp.

**Ag/Renewable Energy Community Events/Projects.** Larson encouraged Ag Committee members to attend the Ag & Animal Science Conference on Tuesday, September 25<sup>th</sup>, 7:30 a.m.-2:30 p.m. at the MinnWest Technology Campus. Schmoll will send out the flyer to committee members.

Chair Tepfer shared Connexus Energy of Ramsey, Minnesota is working on a battery energy storage facility and felt it would be an interesting business to visit. A suggestion was made to invite a Connexus Energy representative to a future Ag Committee meeting.

Keith Poier reported someone is working on a 24-7 solar battery operation for vehicles that use DC power that converts to AC power. When the facility is operational, Poier suggested the Ag Committee plan a visit.

Poier mentioned a settlement award given to an individual who has glyphosate cancer and mentioned a report that found glyphosate (Roundup) in a number of popular breakfast foods and cereals marketed to children. Poier feels this may affect other agriculture products. Larson encouraged committee members to talk to legislators to support research dollars for chemicals.

**ADJOURNMENT**—There being no other business, the meeting was adjourned at approximately 9:10 a.m.
