Chair Pam Rosenau called the meeting to order at approximately 12:04 p.m.

#### MINUTES—

IT WAS MOVED BY Emily Lien, SECONDED BY Tiffany Hintz, to approve the Minutes of the November 27, 2023 meeting as emailed. MOTION CARRIED.

#### **ACTION ITEMS**—

Logo review and recommendation. Kelsey Olson reported the feedback from this committee's previous meeting was shared with Greenwater Garage and logos were redesigned accordingly. Olson met with Kyle Box, City of Willmar Operations Director, to explore integration of rebranding activities. Committee members were asked to vote for a first and second choice of the redesigned logos, recommendations will be presented to the EDC Joint Operations Board on Thursday, December 14, 2023. The logo containing 4 squares with "Kandiyohi County Economic Development" to the right (or underneath for the vertical option) was preferred. Icons within the squares would be too small when used on small swag items such as pens, but the squares could be used without an icon in that instance and would still be recognizable. The use of the letters KCED in the squares was suggested as an alternative. The letters allow more flexibility and would stand out for recognition. The icons used in the squares could be customized to fit the audience and tell the story of what the KCED does. Three versions of the logo will be made, one each for promotional, website and flyer use, including vertical and horizontal options.

IT WAS MOVED BY Emily Lien, SECONDED BY Ann Winge Johnson, to recommend to the Kandiyohi County and City of Willmar Economic Development Commission's Joint Operations Board the logo containing four squares with varying letters or icons used in the squares. The secondary logo will be the same design with squares of a solid color. MOTION CARRIED.

**Color schemes.** The committee preferred "Kandiyohi County" in blue and "Economic Development" in green, with the four squares in varying shades of blue and green. Olson will present logo options with this color scheme, as well as a neutral palette that complements the colors the City of Willmar plans to use in its rebranding process to the EDC Joint Operations Board. This committee recommends the blue and green color scheme, but is willing to support the neutral palette.

**Font.** Discussion was held regarding a new standardized font for EDC marketing literature. The current Raleway font will be discontinued due to its misalignment of numbers. Examples of literature using Raleway, Georgia, Sans Serif and Veranda fonts were presented; however, all four were rejected. Olson then displayed a piece of literature from the Elevate Community Business Academy using Avenir font, which was approved.

IT WAS MOVED BY Ann Winge Johnson, SECONDED BY Ben Carlson, to recommend to the Kandiyohi County and City of Willmar Economic Development Commission's Joint Operations Board that Avenir become the standard font for EDC marketing literature. MOTION CARRIED.

**Tagline.** Olson will email committee members asking for input on the following items:

- Tagline
- Clear and concise statement (for landing page and marketing)
- What We Do pitch
- Action invite (for landing page)

Due to tight deadlines Olson will seek Redwood Valley Technical Solution's help writing website script.

ADJOURNMENT—There being no further business, the meeting was adjourned at approximately 1:42 p.m.
