President Robert Carlson called the meeting to order at approximately 11:00 a.m. and added to the Consent Agenda, under Approve, item 3, payment of invoice from REDstar in the amount of \$1,680.00 and item 4, payment of invoice from EsseX Capital, LLC in the amount of \$2,125 as budgeted for membership in the Community Venture Network and signing of the Agreement for Professional Services.

IT WAS MOVED BY Linda Kacher, SECONDED BY Gary Gilman, to approve the Agenda and revised Consent Agenda. MOTION CARRIED.

Kandiyohi County Economic Profile. Connie Schmoll introduced Luke Greiner, Regional Analyst for Central & Southwest Minnesota Department of Employment and Economic Development (DEED). Greiner stated anyone may obtain information on Kandiyohi County from the DEED website under https://mn.gov/deed/data/regional-Imi/central-Imi.jsp select Region 6E. Greiner presented a PowerPoint presentation on Kandiyohi County's Economic Profile (<u>see</u> attached). Greiner encouraged businesses and agriculture producers to complete surveys sent to them by DEED as the state's data is based on self reporting. Non-employer statistics are self employed individuals. The largest segment of the county's employers are small businesses that employ 1-4 employees. Schmoll distributed DEED's "Central Region: 2016 Manufacturing Highlights" (<u>see</u> attached).

[Greiner was excused from the meeting and Gene West and Paul Rasmussen joined the meeting.]

BNSF Railway Wye Project. Schmoll introduced Gene West, Assistant Project Manager and Paul Rasmussen, Resident Engineer, District 8, Minnesota Department of Transportation (MNDOT). Rasmussen gave a presentation on the Willmar Rail Connector and Industrial Park Access Project (Willmar Wye) (see attached). A big benefit of the project is to provide rail access to Willmar Industrial Park, however, location of the 500 foot railroad spur has not yet been finalized. The Environmental Assessment is in process with plans to hold a public hearing in January 2017. West reviewed three alternative railway connections and road improvements (see maps attached). The main differences between the three alternatives relate to Highway 12 and County Road 55 on the north end. MNDOT staff recommends Alternative 2B. MNDOT is making specific contacts with freight haulers and emergency responders on the proposed routes. Doug Reese noted concerns from citizens about trucks using County Road 5 rather than County Road 55. The next open house on the Wye project is October 18, 2016 at the MNDOT office. West encouraged individuals to review information on MNDOT's website http://www.dot.state.mn.us/d8/projects/willmarwye.

[West and Rasmussen were excused from the meeting.]

PROGRESS REPORTS

Willmar/Willmar Industrial Park. Schmoll informed the board that Aaron Backman is attending a Micropolitan Summit in Owatonna today to see if there is benefit to holding a similar summit in Willmar. Backes Technology Services, Inc. will be building a 4800 square foot facility this fall in the Willmar Industrial Park. Backman is working with the EDC's Marketing and Public Relations Committee on creating a flyer to market the Industrial Park.

Tax Abatement Projects. Schmoll reported the Kandi Mall received the requested 10-year tax abatement from Kandiyohi County and the Willmar School District. They are currently working on drafting the Business Subsidy Agreement. Glacial Ridge Hospitality also received its requested 10-year tax abatement from Kandiyohi County and the New London/Spicer School District and is working on the Business Subsidy Agreement. It was noted the EDC funded a portion of the feasibility study for the hotel to be constructed by Glacial Ridge Hospitality. The Job Creation Fund application by ERC Holdings was approved by the State of Minnesota in the amount of \$563,183 to be used toward renovation of the building owned by Kandiyohi Power Cooperative. Between these projects plus the Spicer hotel project, approximately 350 new jobs will be created in the county.

County Broadband Project. Schmoll reported Consolidated Telecommunications Company (CTC) submitted the Border-to-Border Grant application to the State of Minnesota for \$9,999,993. The State received 62 applications for projects in 37 counties. In addition to CTC's application for Kandiyohi County, TDS Telecom and Frontier Communications submitted applications. TDS Telecom's application was for approximately the same area as CTC's application and Frontier Communications' application was for southern Kandiyohi County. CTC's application included 71 letters of support and 7 videos.

West Central Angel Fund I. Schmoll reported West Central Angel Fund I is reviewing its legal documents and has four individuals in leadership roles and 31 members. The Fund has secured an accounting firm and a bank. Schmoll has two businesses that want to make presentations to the Fund.

Business Visits and Meetings. Schmoll informed the board that MSNBC was in Willmar last week to do a program on the diverse business community. Backman visited several minority-owned businesses, including Estrella Bakery, La Fiesta Foods, La Michoacana, Ainu-Shams, Samah Home Health Care and West Central Interpreting Services. Schmoll and Backman both participated in the Willmar Lakes Area Chamber of Commerce's Ag tours. Yesterday, Schmoll, Backman and the EDC's Workforce Subcommittee hosted 400 Willmar High School 10th graders at eight manufacturers. Schmoll reported she toured JMD Manufacturing this week.

UNFINISHED BUSINESS—Linda Kacher requested Backman follow up on several items recommended by the auditor at last month's meeting that needed to be done following the annual audit.

New Business—There was no new business.

COMMITTEE REPORTS

Ag Producers' Survey Subcommittee. Rollie Boll reported the subcommittee is raising funds to help conduct the survey and are looking for volunteers to help do the interviews. Board members voiced concern about the agriculture field and ability to secure financing. Schmoll stated Jim Molenaar has been secured to evaluate the survey data as he did in 2005.

Broadband and Advanced Technology. Schmoll stated the committee will be inviting TDS Telecom and Frontier Communications to attend a future committee meeting to discuss the projects they have planned for Kandiyohi County in the next few years.

BRE/R. Schmoll stated Sam Bowen was selected as the committee's new chair. The committee has changed its meetings to the third Friday of each month in hopes of gaining more participation.

Workforce Subcommittee. Schmoll reported the subcommittee completed the student tours. The Willmar High School would like the tours to continue and other area schools would also like to participate.

Finance. Gary Gilman reported the committee met and discussed the defaulted loan under the Entrepreneurs' Loan Guarantee Program. Schmoll informed the board of the committee's recommendation to pay the guarantee.

IT WAS MOVED BY Art Benson, SECONDED BY Rollie Boll, that the Kandiyohi County and City of Willmar Economic Development Commission pay to United Minnesota Bank the guarantee of \$23,253.88 from the Entrepreneurs' Loan Guarantee Program reserves for the defaulted loan of Inspirations Books & Gifts. MOTION CARRIED with Robert Carlson abstaining.

Gilman noted steps have been taken to limit such losses by requiring life insurance on the debtor. Gilman stated Backman is discussing the progress of remodeling The Hub with the Preservation Alliance of Minnesota and Willmar Downtown Development so tenants can open their businesses.

Marketing and Public Relations. Donna Boonstra reported the main item being worked on is a flyer for the Industrial Park.

Leisure Travel. Art Benson stated he was unable to attend the meeting.

Central Region: 2016 Manufacturing Highlights

October 5, 2016

(http://www.mn.gov/deed/newscenter/infographics/manufacturing-infographics/central-info.jsp)Manufacturing is the second largest industry in Central Minnesota, behind health care and social assistance. With 41,473 jobs at 1,147 firms, manufacturing accounts for 15.5 percent of all employment in the region. That is much more concentrated than in the state as a whole, where 11.4 percent of total jobs are in manufacturing.

From 2011 to 2015, manufacturers in Central Minnesota added 4,675 new jobs, an increase of 12.7 percent. Food manufacturing and fabricated metal products are the largest manufacturing subsectors in the region with 18.5 and 16.9 percent of manufacturing jobs, respectively.

Manufacturing is one of the highest paying industries in the region. Total payroll in manufacturing neared \$2.1 billion in 2015. That accounted for 19.5 percent of total wages in Central Minnesota.

Average annual wages in manufacturing in the region were \$50,336 in 2015. That was 26.2 percent higher than average annual wages across all industries. Manufacturing wages in the region increased 9.9 percent from 2011 to 2015, compared to an overall increase of 12.5 percent.

Central Spotlight: Advancing the Global Economy with Advanced Manufacturing

Manufacturers in Central Minnesota produce everything from poultry to precision parts, however a cluster of manufacturing sectors collectively known as "advanced manufacturing" is special to Central Minnesota's manufacturing community.

Advanced manufacturing includes sub-sectors such as fabricated metal products, machinery, computer and electronic products, electrical equipment, appliance, and components, transportation equipment and miscellaneous manufacturing.

Although food manufacturing is the largest sub-sector in the region, when the sub-sectors within advanced manufacturing are combined, employment reaches 18,824 jobs – more the double the employment found in food manufacturing. Advanced manufacturing not only has a large number of jobs (45 percent of all manufacturing jobs in the region), but the sector is growing faster than manufacturing in general.



In the last year, Central Minnesota's job growth across all industries amounted to 1.7 percent, while manufacturing grew by 2.3 percent, and advanced manufacturing growth was 2.5 percent from 2014 to 2015. Half of all new jobs in manufacturing over the last year were due to advanced manufacturing companies expanding their payrolls.

Average annual wages for advanced manufacturing were \$53,442 in 2015, up 5.7 percent from 2014. In comparison the average annual wage for all industries in Central Minnesota was just under \$40,000 while manufacturing jobs averaged a little more than \$50,000 (see Figure 1).






In the second quarter of 2016, manufacturers reported 839 job openings, up from 610 openings reported during the second quarter of the previous year. The median wage offer for job vacancies was nearly the same at \$15 per hour. Only 3 percent of manufacturing openings in the region were posted as part-time, while 37 percent required education

beyond a high school diploma/GED, and 48 percent required at least one or more years of experience.

Typical occupations found in advanced manufacturing facilities include team assemblers, machinists, welders, CNC operators, and industrial, mechanical and electrical engineers. These occupations are not exclusive to advanced manufacturing, however, and are also found in a variety of other sectors of manufacturing.

Figure 2 (below) illustrates the large range of hourly wages that can be earned by common occupations in advanced manufacturing. With roughly 2,200 jobs apiece, team assemblers and welders are the most numerous occupations in Central Minnesota, with wages ranging between \$12 and \$25 per hour. There are 440 mechanical engineers in Central Minnesota, with a median hourly wage of \$33.46, and the top 10 percent earning \$81.23 or more per hour.



While the global economy leans on advanced manufacturing to produce everything from buses and trailers to stainless steel tanks used in breweries and dairies, Central Minnesota can count on this sector to provide ample job opportunities with excellent wages.


