Chairperson Sam Bowen called the meeting to order at approximately 9:07 a.m.

AGENDA

IT WAS MOVED BY Kelly TerWisscha, SECONDED BY Ranae Rahn, to approve the agenda as emailed. MOTION CARRIED.

MINUTES

IT WAS MOVED BY Roger Imdieke, SECONDED BY Kelly TerWisscha, to approve the minutes of August 4, 2017 as emailed. MOTION CARRIED.

REPORTS/PROJECT UPDATES

Historic 313. Backman reported Foxhole Brewhouse is progressing on constructing additional storage space and visiting areas and its first anniversary celebration was well attended. The Spurs Restaurant construction is expected for completion sometime in September. Backman shared the St. Cloud restaurant prospect will make another visit to Historic 313 early this fall.

Midtown Plaza. Backman reported the renovation of the first floor is making good progress and one of the anchor tenants, a Somali grocery store, is expected to open in September and will be one of the largest Somali grocery stores in the area. Backman suggested the BRE/R Committee conduct a meeting at Midtown Plaza in approximately two months.

Highway 23 Coalition. Backman reported Highway 23 Coalition membership letters were mailed to units of government along the corridor and some businesses/organizations (see attached) and shared the membership responses have been going well. There are a total of 67 entities to far that could be potential members. To date, six units of government, two organizations and eight businesses have joined the coalition at various levels of commitment. Backman and Connie Schmoll will present the Highway 23 Coalition membership to other city councils and townships in the near future. Les Heitke commented the main focus is to complete the two gaps and inquired of the intent to lobby with cities along the corridor. Backman concurred the first priority is to complete the gaps and to actively support funding for other cities' projects/priorities and feels the more partners that are involved, Highway 23 will have a better voice. Backman announced a Highway 23 Coalition meeting will be held 7:30 a.m., Thursday, September 28, 2017, at McKale's Restaurant in New London. The focus of the meeting will be to work on a contract between the Highway 23 Coalition and Mid-Minnesota Development Commission (MMDC). On October 13, MNDOT Transportation Commissioner, Charlie Zeller, and other Minnesota Department of Transportation (MnDOT) and local dignitaries and will attend a luncheon at O'Neil's Event Center in Spicer.

Business Visits/Tours. Backman shared highlights of recent business visits/tours and meetings: Backman attended the Public Policy meeting; TED Project and Funding/Application meeting at MnDOT; Blue Zone meeting with Joanna Schrupp and Leslie Valiant; Vision 2040 Housing Subcommittee meeting; meeting to reaffirm of tax abatement (new time frame established) of Glacial Ridge Hospitality. Met with the Regional Director of Otto Bremer Trust and toured part of the downtown. The opportunity came from the Diverse Business BRE Report. Further discussions will be held in the future. Met with Andy Weiner of RockStep, Larry Kleindl and two Kandiyohi County Commissioners and others regarding an update on the Kandi Mall rehabilitation projects: 1) possible major tenants are interested in the former K-Mart space; 2) new BBQ business will open in the former yogurt location; 3) new retail building near the former Pizza Hut. Jim Ellingson inquired of possible tenants for the former Pizza Hut building and Backman replied there are no potential tenants to date. Mr. B's Chocolates is open to the public at MinnWest Technology Campus; however, its focus will be mostly online sales. Backman and Jill Bengtson, Executive Director of Kandiyohi County/McLeod County/Willmar HRA, toured various sites in Raymond, Spicer and Atwater for possible affordable housing projects. Attended an event at the new Pavilion at Prairie Woods Environmental Learning Center.

UNFINISHED BUSINESS

Workforce Training Program with CLUES/Ridgewater College. Chair Bowen shared copies of a CLUES PowerPoint prepared by John Pacheco (see attached). The mission of the organization is to advance the capacity of families to be healthy, prosperous and engaged in their communities. CLUES is currently in the metro area and now Wilmar. The Certified Nursing Assistant (CNA) program will begin in October and is open to a limited number (10) of Latino students at no cost. The program is also open to other ethnic groups. Upon completion of the program, students are guaranteed an interview. Partners include the Workforce Navigator; education partner, Ridgewater College; employee sponsors, Bethesda and Rice Memorial Hospital. Chair Bowen invited BRE/R members to a Kickoff Open House on September 7, 1-3 p.m., at Ridgewater College. He also

distributed a flyer regarding the CLUES CNA program (<u>see</u> attached) and encouraged committee members to share with others.

West Central Job Fair. Chair Bowen shared information on the upcoming West Central Job Fair scheduled for September 19, 2017 at the Willmar Conference Center (see attached). Bowen asked for suggestions to better reach more qualified and a larger pool of job candidates. Backman shared past job fairs included employers from manufacturing, healthcare and trucking industries. Discussion held regarding the 2018 job fair(s). One suggestion was to have two job fairs; one in the Fall at Ridgewater College (noon) and one in Spring at the Willmar Conference Center (later afternoon) which would reach various demographic areas. Suggestions included a passport-type incentive for attendees and offer lunch/refreshments at the conclusion of their visit and hands-on demonstrations, i.e., heavy equipment, etc. BRE/R members concurred the need to get the message out to a broader audience and the use of social media. Chair Bowen will contact KDJS to obtain the employment results from the 2016 Job Fair.

New Business

Backman reported the Minnesota Association of Professional County Economic Developers (MAPCED) will hold its annual meeting on September 22, 2017, at Dooley's new executive office in Willmar. A bus tour will include the Destination Playground, WORKUP, Mr. B's Chocolates, Barn Theatre and Historic 313. Backman reported the Grand Stay Hotel in New London is moving forward.

Dear Business Leader:

An informal Highway 23 Coalition has been seeking state funding to complete the two four-lane gaps between Willmar and Interstate 94 for many years. The Coalition has now formally organized and has elected officers, established a budget and incorporated a membership structure.

Highway 23 is the second longest state route in Minnesota traveling from the South Dakota border to Duluth and, yet, the majority of the route remains a two-lane highway. At this time, the Highway 23 Coalition has chosen to focus on the corridor from Marshall to I-94. The Coalition is focusing its first efforts on a continuous four-lane connection from Willmar to I-94, which it believes is essential to West Central Minnesota's economy and workforce. In the six-county region, more than 1,138 transportation-related businesses with 30,000 employees will directly benefit. Accessibility is required to attract and retain manufacturing jobs, businesses and skilled employees and often a requirement for businesses such as yours.

The Coalition has adopted an initial budget of \$31,100, a copy of which is enclosed. A majority of the budget will come from membership dues from units of government, businesses and organizations. For businesses and organizations, there are four levels of membership:






LATINO WORKFORCE INITIATIVE IN GREATER MINNESOTA

- Expand culturally tailored programs that address employment and education skills gaps for working parents and underserved youth.






WILLMAR



- The Navigator meets at least once a week throughout the training and continues to follow up & support you for one year past job placement




