Vice Chairperson Steve Gardner called the meeting to order at approximately 11:15 a.m. and declared a quorum was present.

**Business Development Manager Position.** The board received the resignation letter by Sarah Swedburg (see attached).

IT WAS MOVED BY Vicki Davis, SECONDED BY Doug Reese, to accept, with regrets, the resignation of Sarah Swedburg as Business Development Manager of the Kandiyohi County and City of Willmar Economic Development Commission. All present voted unanimously in favor by roll call.

Backman presented the Job Description for the Business Development Manager position (see attached).

IT WAS MOVED BY Julie Asmus, SECONDED BY Doug Reese, to ratify the Business Development Manager Position Description for the Kandiyohi County and City of Willmar Economic Development Commission as presented. All present voted unanimously in favor by roll call.

Backman presented the ad that has been posted with Association of Minnesota Counties, League of Minnesota Cities, Economic Development Association of Minnesota, Minnesota Association of Professional County Economic Developers, LinkedIn, JobsHQ and the Willmar Lakes Area Chamber of Commerce. Backman has had conversations with six potential candidates. Resumes and applications are due by January 19, 2024. Backman would like the Review Committee to meet the week of January 22 and hold interviews the end of January or beginning of February.

IT WAS MOVED BY Roger Imdieke, SECONDED BY Vicki Davis, to ratify the ad that was posted for the Business Development Manager position for the Kandiyohi County and City of Willmar Economic Development Commission. All present voted unanimously in favor by roll call.

Backman noted the Joint Operations Board formed a Review Committee. Representatives on the committee thus far are Mary Warszynski, Les Heitke and Joint Powers Vice Chair Gardner. Davis and Corky Berg volunteered to also serve on the committee. Backman noted the committee will review the resumes, interview the applicants and recommend an applicant for approval by this board.

IT WAS MOVED BY Roger Imdieke, SECONDED BY Vicki Davis, to appoint the following to serve on a Review Committee: Corky Berg, Vicki Davis, Steve Gardner, Les Heitke and Mary Warszynski with Doug Reese serving as alternate, if needed. All present voted unanimously in favor by roll call.

**EDC Rebranding/Logo.** Kelsey Olson presented the Brand Guide (<u>see</u> attached) approved and being recommended by the EDC's Marketing and Public Relations Committee. Olson noted the logo with solid color boxes will be used in some marketing materials when the initials or icons would be too small to recognize. She showed examples of marketing materials and spoke on how the colors were selected. The colors compliment logos of other local organizations and she has had conversations with Kyle Box of the City of Willmar as to the City's new logo that is being considered. Olson will add Regal and Svea to the list of communities in the Brand Guide. Olson will be working with the community partners to define the EDC's partnership with those organizations. Olson invited the boards to help identify the EDC's tangibles (work done), intangibles (feelings) and universal concepts (making dreams come true, supporting innovation, sense of community) and suggested tag lines.

Backman noted at the November 20<sup>th</sup> special meeting of this board it unanimously approved the new agency name of "Kandiyohi County Economic Development" and the use of it in our marketing and published materials. Today Backman requested the board approve the new logo and brand guide. Berg requested that it be made clear that the EDC is a joint powers venture with the City of Willmar and somehow note it on materials.

IT WAS MOVED BY Roger Imdieke, SECONDED BY Corky Berg, to approve the logo and Brand Guide as presented for the Kandiyohi County and City of Willmar Economic Development Commission. All present voted unanimously in favor by roll call.






