FINANCE COMMITTEE MINUTES

January 14, 2025 KCED Office, Willmar, and Via Zoom Video Conference

Chairperson Kerry Johnson called the meeting to order at approximately 12:05 p.m. and announced a quorum was present.

AGENDA—Added to the Agenda under New Business were the following items: d. Kandi Adult Care; e. loan payoffs and f. election of officers.

IT WAS MOVED BY Chris Radel, SECONDED BY Allen Huselid, to approve the revised Agenda. MOTION CARRIED.

Self introductions were done with Rollie Nissen being introduced as the new committee member representing the KCED Joint Operations Board.

MINUTES—

IT WAS MOVED BY Allen Huselid, SECONDED BY Nate Reuss, to approve the November 12, 2024 Minutes as emailed. MOTION CARRIED.

UNFINISHED BUSINESS—There was no unfinished business.

NEW BUSINESS

Simply Shrimp loan request. Michelle Marotzke presented the loan request of Simply Shrimp for \$50,000 from the EDC's Revolving Loan Fund. It is a \$6.8 million project. Federated Telephone Cooperative has approved a loan of \$200,000. Paul Damhof noted financing is being requested from four other investment groups, all of which would like an ownership interest in the business. Damhof is doing his due diligence relative to the financing and finding people who have the same vision and outlook for his business. Damhof is also working with Southwest Initiative Foundation (SWIF), Citizens Alliance Bank and the Small Business Administration (SBA). Damhof gave his background in the shrimp business that started in 2017 with a grow facility. He is now focusing on the hatchery and has been working with Kelly TerWisscha of TerWisscha Construction over the past four years. He noted Nova-Tech Engineering has designed a processing machine that will dehead and devein shrimp that will be sold worldwide—this process has been done by hand up until now. Working capital is included in the total financing request. He has several restaurants interested in his product. Self distribution will be done as much as possible plus direct sales via the internet. There are funds in the budget for a freezer truck. Damhof is very confident in the numbers he has stated for meat production. TerWisscha noted the biggest issue for the first year is the water. Damhof is working through the United States Department of Agriculture (USDA) Risk Management Agency for federal crop insurance—aquaculture has not been included to date.

[Damhof was excused from the meeting.]

Marotzke noted Damhof has 30-60 days to get all financing approved. He would like to get construction started this spring. Chair Johnson shared the approval process for an SBA loan, which will more than likely take 90 days. TerWisscha noted SBA is in favor of the project. Marotzke stated Scott Marquardt of SWIF is in favor of the project and may do more financing than initially requested. The committee reviewed the KCED Balance Sheet as of December 31, 2024 (see attached) and the funds available for lending. TerWisscha estimated construction will take six months as there is a lot of large piping that needs to be done.

IT WAS MOVED BY Chris Radel, SECONDED BY Allen Huselid, to approve a \$50,000 ten-year loan from the Kandiyohi County and City of Willmar Economic Development Commission's Revolving Loan Fund to Simply Shrimp at 6.5% interest with a fourth position security interest, contingent upon all other financing being secured, including approval by the Small Business Administration with closing to occur in 120 days. An extension may be requested, if needed. Interest-only payments are approved for the first nine months. MOTION CARRIED with Kelly TerWisscha abstaining.

VP Enterprises update. Marotzke informed the committee that she received information from Laura Warne of Home State Bank that VP Enterprises is working on an auction of its assets. It will be doing an inventory of its assets over the next two weeks and a 30-day auction will be held on K-BID. It was suggested to formally put a 90-day deferment on its KCED loan. Marotzke has not been in contact with the owners, but they are communicating with Home State Bank. Warne believes all creditors will be made whole.

Aesthetics by Ash update. Marotzke noted that shortly after the loan was approved, Ashlyn Hillenbrand's vehicle quit working. She has been working with SWIF as the vehicle was collateral on its loan. She is looking at closing her loan the first part of February.

IT WAS MOVED BY Nate Reuss, SECONDED BY Kerry Johnson, to approve a 60-day extension to close the loan to Aesthetics by Ash. MOTION CARRIED.

Kandi Adult Care. Marotzke reported the final payment of \$91.66 is due from Kandi Adult Care under its loan through the COVID-19 Business Assistance Loan (COBAL) program. She has made several requests for this final payment, but no response has been received. She recommends the balance of the loan be written off.

IT WAS MOVED BY Chris Radel, SECONDED BY Rollie Nissen, to write off the remaining balance of \$91.66 owed by Kandi Adult Care under the COVID-19 Business Assistance Loan program. MOTION CARRIED.

Loan payoffs. Marotzke reported Wings Gymnastics paid off its loan with the KCED and New Minnesotan Realty's loan was also paid in full. The committee received and reviewed the outstanding loan charts for the Revolving Loan Fund and Microenterprise Loan Program.

Election of officers.

IT WAS MOVED BY Chris Radel, SECONDED BY Kelly TerWisscha, to re-elect Kerry Johnson as chairperson of the Kandiyohi County and City of Willmar Economic Development Commission Finance Committee. MOTION CARRIED.

Fund availability. Marotzke reviewed the availability of loan funds as shown on the December 31, 2024 Balance Sheet. She noted the \$40,000 Certificate of Deposit at Concorde Bank has been set aside for a possible loan to Clean Chickens.

IT WAS MOVED BY Rollie Nissen, SECONDED BY Allen Huselid, to move the funds in the COVID-19 Business Assistance Loan (COBAL) fund at Lake Region Bank to the account from which they originally originated and to close the account at Lake Region Bank. MOTION CARRIED.

USDA Rural Development Intermediary Relending Program. Marotzke has spoken with Jill Bengtson, Director of the Kandiyohi County Housing and Redevelopment Authority (HRA) as to expanding its Intermediary Relending Program (IRP) to include all of Kandiyohi County rather than just downtown Willmar. The KCED may offer assistance in some way. Bengtson has spoken with the USDA relative to making this change.

ADJOURNMENT—There being no other business, the meeting was adjourned at approximately 1:15 p.m.
